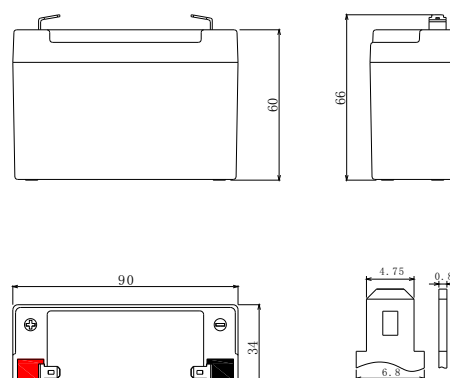

Battery use

Cycle use

1. Limit the initial charging current to no more than 1.05A
2. Keep charging voltage at 4.80-5.00V/ unit, and continue charging at least 3 hours after the charging current reduces to 0.07A to ensure full charge
3. The compensation coefficient of charging voltage and temperature is -5mv/cell /°C

Float use

1. Limit the initial charging current to no more than 1.05A
2. Keep charging voltage at 4.50-4.60V/unit. When the voltage reaches the constant voltage, the current gradually decreases until the battery is fully charged and continues to charge
3. The compensation coefficient of charging voltage and temperature is -3mv/cell /°C

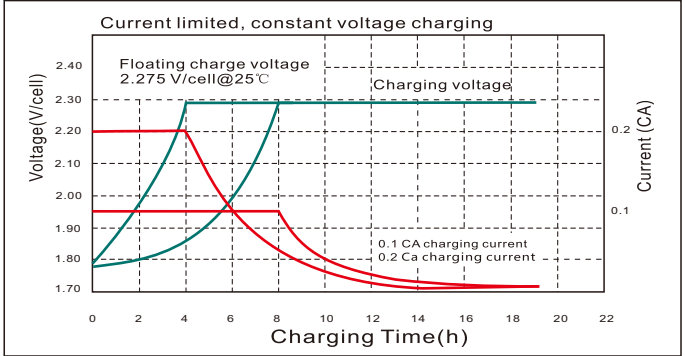

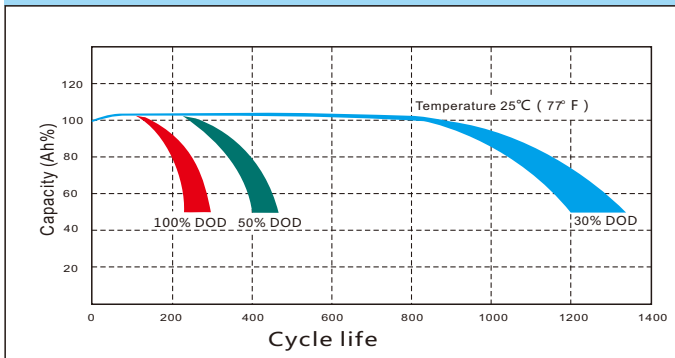
Floating Charging Life VS Temperature



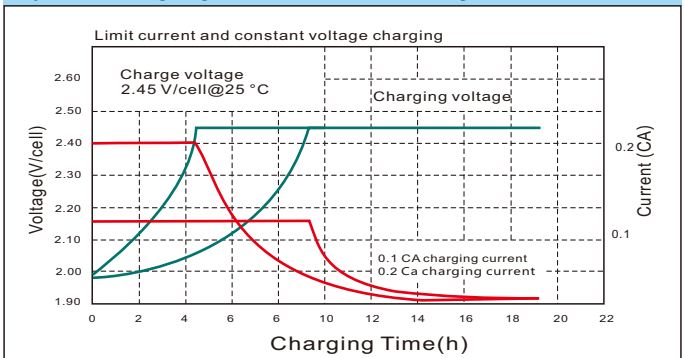
Floating Charging Characteristics Diagram



Cycle Life



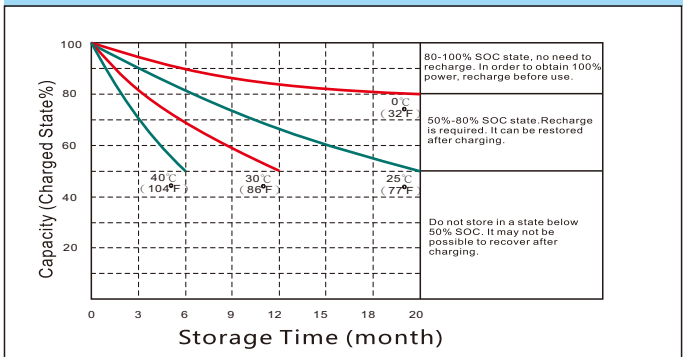
Cycle charging characteristic diagram
